Stewards' Notice

Stewards' Inquiry

Determination of Inquiry – Person 252061

On 7th July 2022, Greyhound Racing SA Stewards heard and determined an Inquiry with respect to the conduct of 252061, regarding the greyhounds 475985, 493992 and 508440.

Stewards conducted an Inquiry relating to the health and welfare of the greyhounds 475985, 493992 and 508440, and associated conduct.

252061 did not attend the Inquiry, as required, on 7th July 2022.

Stewards found sufficient evidence to charge 252061 with –

- (1) Fail to attend Inquiry on 7th July 2022 (GAR 164(b));
- (2) Fail to comply with a lawful order of a welfare compliance officer between 31st May 2022 and 11th June 2022 (GAR 156(h));
- (3) Fail to provide necessary veterinary attention to the greyhound 475985, between 11th May 2022 and 1st July 2022 (GAR 21(1)(d));
- (4) Ill treat the greyhound 475985 between 11th May 2021 and 1st July 2022 (Local Rule 131(2));
- (5) Fail to provide necessary veterinary attention to the greyhound 493992, between 11th May 2022 and 1st July 2022 (GAR 21(1)(d));
- (6) Ill-treat the greyhound 508440 between 31st day of August 2022 and 1st July 2022 (Local Rule 131(1));
- (7) Fail to provide necessary veterinary attention to the greyhound 508440, between 31st August 2021 and 1st July 2022 (GAR 21(1)(d));
- (8) Insult officer of the Controlling Body on 30th June 2022 (GAR 156(g)(ii));
- (9) Engage in conduct detrimental to the welfare of greyhound racing on 30th June 2022 (GAR 165(a)).

Stewards heard charges-(1), (2), (8) and (9) *ex-parte* and found those charge substantiated.

Stewards noted that 252061 was not active in the greyhound racing industry and did not possess any greyhounds at the time of the Inquiry. Having regard to the nature of the offences and 252061's involvement in the industry, Stewards order the following penalties –

- (1) Registration cancelled;
- (2) Fine \$1,500.00, cumulative to all other fines imposed;
- (8) Fine \$250.00, cumulative to all other fines imposed;
- (9) Fine \$250.00, cumulative to all other fines imposed;

The total fine is \$2,000.00.

252061 will not be considered for further registration, and is suspended, unless and until he attends an Inquiry in relation to the remainder alleged offences (3) to (7); and further, he satisfies the fit and proper person test as required pursuant to the Local Rules, to the satisfaction of the Controlling Body.
