Stewards' Notice

Allegations of ill-treatment of greyhounds

Greyhound Racing SA Limited (GRSA) today continued the Inquiry in relation allegations of ill-treatment of greyhounds on a property of a registered person.

On Thursday, 27th July 2023, GRSA continued its Inquiry opened on 26th July 2023, and laid the following charges, pursuant to the *Greyhounds Australasia Rules* (GAR) and *Local Rules* (LR) –

Person A

- 1) Ill treatment of a greyhound (Rule 131(2), *Local Rules*);
- 2) Ill treatment of a greyhound (Rule 131(2), *Local Rules*);
- 3) Ill treatment of a greyhound (Rule 131(2), *Local Rules*);
- 4) Ill treatment of a greyhound (Rule 131(2), *Local Rules*);
- 5) Ill treatment of a greyhound (Rule 131(2), *Local Rules*);
- 6) Fail to exercise care and supervision of a greyhound to prevent pain or suffering (Rule 21(2), *Greyhounds Australasia Rules*);
- 7) Cause or permit on premises a condition dangerous to health, welfare or safety of a greyhound (Rule 21(3), *Greyhounds Australasia Rules*);
- 8) Conduct detrimental to the interest, welfare, image, control or promotion of greyhound racing (Rule 165(1), *Greyhounds Australasia Rules*).

Person B

- 1) Ill treatment of a greyhound (Rule 131(2), *Local Rules* with Rule 156(e), *Greyhounds Australasia Rules*);
- 2) Fail to exercise care and supervision of a greyhound to prevent pain or suffering (Rule 21(2), *Greyhounds Australasia Rules*);
- 3) Cause or permit on premises a condition dangerous to health, welfare or safety of a greyhound (Rule 21(3), *Greyhounds Australasia Rules*);
- 4) Conduct detrimental to the interest, welfare, image, control or promotion of greyhound racing (Rule 165(1), *Greyhounds Australasia Rules*).

The inquiry has been adjourned to a date to be fixed, for Stewards to continue investigations and refer the matter to GRSA's Integrity Hearings Panel (IHP) for determination.

Suspension for the two registered persons, in place since the opening of the Inquiry on 26th July 2023, remain in effect, as does the restriction over the associated property to keep or train greyhounds.
