General Stewards conducted an inquiry into an alleged incident between licenced owner attendants Mr. Lance Simpson and Mr. Peter Hannagan which took place in Chasers restaurant. After taking evidence from Mr. Simpson and Mr. Hannagan, and viewing CCTV footage of the incident, Stewards found there was sufficient evidence to lay charges against both parties under GAR 86(o), the particulars of the charge being that Mr. Hannagan and Mr. Simpson both engaged in an altercation with each other in Chasers restaurant which in the opinion of the Stewards constitutes misconduct. After taking into account their guilty pleas, clean record under this rule, remorse shown, and personal circumstances, Stewards fined Mr. Simpson \$200 and suspended him for 1 month, with the suspension wholly suspended for a period of twelve (12) months provided Mr. Simpson does not reoffend under this rule. Stewards fined Mr. Hannagan \$200 and suspended him for one (1) month, with the suspension wholly suspended for a period of twelve Mr. Hannagan does not reoffend under this rule.
