- SUNSET ANGEL and VEE POWER began slowly. Shortly after the start LITTLE LINA moved down checking IROQUOIS SHARMAN and NOLEN BAY. Along the back straight NOLEN BAY moved down checking KYNAN'S RETURN. On the turn off the back straight VAL'S LEGEND eased appearing injured.
- VAL'S LEGEND was vetted after the race. REPORTED TO BE INJURED AND WAS SUSPENDED FOR 28 DAYS ALL TRACKS.

Approaching the turn off the back straight PENNY LA MOMENT checked around the heels of AVATAR DEMON then shortly after DESIGN A DREAM moved down across the running line of MUSTANG BAY causing MUSTANG BAY to run on the heels of DESIGN A DREAM dragging it down.
- SWEET EMMA was vetted after the race, REPORTED TO BE INJURED AND WAS SUSPENDED FOR 10 DAYS ALL TRACKS.

EARLY SCRATCHINGS NIL

- Approaching the first turn COPPER TYCOON moved out checking MORRIS PEER then shortly after CONSOLIDATE moved down checking MORRIS PEER. On the turn into the back straight STOCKWHIP SALLY moved down across the running line of KATHY'S LADY causing KATHY'S LADY to run onto the heels of STOCKWHIP SALLY, dragging it down. As STOCKWHIP SALLY dropped back through the field MONGOLIAN BAY made heavy contact with STOCKWHIP SALLY resulting in both greyhounds losing considerable ground, with STOCKWHIP SALLY worst affected.
