-SPRING FAIR was slow to begin. Shortly after the start YARINDALE moved out checking SHAHAKA causing SHAHAKA to stumble. On the turn into the home straight HUEY LEE moved out checking YARINDALE.
-SHAHAKA was vetted after the race with NO INJURY DETECTED.

-A swab sample was taken from the winner PERSONALITY.
-On the first turn DOUBLE ELEVEN ran onto the heels of DASHING RAMBO. There were no further racing incidents to report.
-DOUBLE ELEVEN was vetted after the race with NO INJURY DETECTED.
-Stewards questioned Trainer Ms. S Gray regarding the performance of DOUBLE ELEVEN. Ms. Gray was advised the future performance of the greyhound would be monitored.

-A swab sample was taken from the winner SALE GRAZE BINDI.
-SALE GRAZE BINDI was slow to begin. On the turn into the home straight on the first occasion COCO SPECTRE and MASTER CHAOS bumped. On the turn out of the home straight MY BOY BEAN moved out checking MASTER CHAOS causing MASTER CHAOS to stumble, shortly after COCO SPECTRE moved out bumping MASTER CHAOS. Approaching the turn into the home straight on the final occasion SALE GRAZE BINDI moved down checking WEST ON BAMBOO.
-MASTER CHAOS was vetted after the race, REPORTED TO BE INJURED AND WAS STOOD DOWN FOR 30 DAYS.
-EQUILIBRIUM was vetted after the race with NO INJURY DETECTED.
-Stewards questioned Mr. T Murray regarding the racing manners of EQUILIBRIUM along the home straight on the final occasion. Stewards noted the on track veterinarian was unable to examine the greyhound immediately after the race as he was attending to the dislocated toe of MASTER CHAOS and was therefore unable to ascertain if the greyhound had cramped during the run. Mr. Murray stated that it was the greyhounds first run for three months and that he believed the weather conditions hindered the greyhound's performance. Stewards noted Mr. Murray's comments and advised him that the future performance of the greyhound would be monitored.

-On the first turn CANYA CHASE made contact with the running rail then shortly after DYNA ADRIA moved down checking GEMTREE DYNAMO and FANTASTIC YANKEE, shortly after YOU DEE ELLE and GEMTREE DYNAMO bumped. On the turn into the back straight COME HOME moved down checking FANTASTIC YANKEE then shortly after GEMTREE DYNAMO moved down checking YOU DEE ELLE. On the turn off the back straight NO PASSENGERS moved down checking DYNA ADRIA which then moved out checking YOU DEE ELLE. Approaching the turn into the home straight GEMTREE DYNAMO was held up for a run behind FANTASTIC YANKEE. On the turn into the home straight GEMTREE DYNAMO and DYNA ADRIA bumped.
-CANYA CHASE was vetted after the race with NO INJURY DETECTED.

STEWARDS NOTES	Stewards questioned trainer Mr. Colin Swain who allowed an unregistered person, Mr. Dean Decrea, to gain access into a restricted area following Race 4, where Mr. Swain allowed Mr. Decrea to touch the greyhound EBBY LAMAR. Mr. Swain stated that Mr. Decrea had no connection with the greyhound EBBY LAMAR, he was aware that Mr. Decrea was unregistered and was simply a long-time associate of himself. Stewards also questioned Mrs. Shirley Segreto who is recorded as the registered owner of EBBY LAMAR. She stated the greyhound was wholly owned by her and she was unaware of who Mr. Decrea was or what his connection was to EBBY LAMAR. Stewards noted Mrs. Segreto's explanation. Mr. Swain was reminded of his obligations as a registered person.
