-Shortly after the start DIAMOND HEART moved down checking COLLECTING. On the turn into the home straight AMERICAN MAN raced wide.

-A swab sample was taken from the winner SPRINGVALE JORJA.

-SEE YOU SMILE and BILLIE BURNER were both slow to begin and TOP RIGHT went up with the lids. Shortly after the start SPRINGVALE VIXEN moved out checking GOLLY GUMDROPS. On the first turn SPRINGVALE VIXEN moved out checking CHRISTIE'S LAD and then CHRISTIE'S LAD checked around the heels of SPRINGVALE VIXEN. On the turn into the back straight GOLLY GUMDROPS and CHRISTIE'S LAD came together resulting in CHRISTIE'S LAD being checked. Along the back straight SEE YOU SMILE stumbled.

-SEE YOU SMILE was vetted after the race with NO INJURY DETECTED.

Stewards acting under GAR 69(2)(b) SUSPENDED PHIL'S GREEN FOR 90 DAYS ALL TRACKS AND UNTIL THE COMPLETION OF A SATISFACTORY TRIAL.

-PHIL'S GREEN was vetted after the race with NO INJURY DETECTED.

-REGAZZONI was vetted after the race, REPORTED TO BE INJURED AND WAS STOOD DOWN FOR 7 DAYS.
