<b>Race 1</b>	<b>YOU. ME. 6 WEEKS. MAIDEN STAKE</b>	<b>395m</b>	<b>Maiden</b>

-A swab sample was taken from the winner AINSLEY FLASH.  
-CAWBOURNE ROXY was very slow to begin. At the point of the turn CAWBOURNE ROXY ran on the heels of CLARETOWN MAGIC losing ground as a result.

<b>Race 2</b>	<b>DAISH IRRIGATION AND FODDER STAKE</b>	<b>395m</b>	<b>Grade 6</b>

-Shortly after the start FINNISS FINESSE moved down checking MAKING DOUGH. On the turn into the home straight MAKING DOUGH and MCALPINE ran wide and continued wide along the home straight. There were no further racing incidents to report.

<b>Race 3</b>	<b>KURT DONSBERG PHOTOGRAPHY STAKE</b>	<b>395m</b>	<b>Grade 6</b>

-LEFEVRE LILL was slow to begin. On the point of the turn STITCH 'EM ROLLO checked around the heels of RUSTY FURY then moved out checking LEFEVRE LILL causing both greyhounds to run wide, then GOLDEN KRUGER moved out checking CALAIS PERUZZI causing both greyhounds to run wide shortly after THEY CALL ME turned its head outwards at WESTGATE GIRL and was reported for failing to pursue, THEY CALL ME then moved out checking WESTGATE GIRL, CARDHU TOO and CALAIS PERUZZI causing WESTGATE GIRL to stumble and CALAIS PERUZZI to fall. On the turn into the home straight RUSTY FURY checked around the heels of CARDHU TOO then moved out bumping THEY CALL ME. CALAIS PERUZZI regained its footing and completed the course.  
-WESTGATE GIRL was vetted after the race, REPORTED TO BE INJURED AND WAS STOOD DOWN FOR 30 DAYS.  
-CALAIS PERUZZI was vetted after the race, REPORTED TO BE INJURED AND WAS STOOD DOWN FOR 14 DAYS.  
-THEY CALL ME was vetted after the race, REPORTED TO BE INJURED AND WAS STOOD DOWN FOR 21 DAYS. Stewards acting under GAR69B(1)(a) SUSPENDED THEY CALL ME FOR 21 DAYS ALL TRACKS AND UNTIL THE COMPLETION OF A SATISFACTORY TRIAL.

<b>Race 4</b>	<b>METRO ROLLER DOORS STAKE</b>	<b>395m</b>	<b>Grade 6</b>

-On the first turn NO KNOWLEDGE moved out checking BELLA PERUZZI, BABY BROOKE, ZOLTAN and MAXIMUS causing BABY BROOKE to be turned sideways. On the point of the turn NO KNOWLEDGE ran onto the heels of OAKVALE ELITE.  
-CAWBOURNE TOE was vetted after the race with NO INJURY DETECTED.

-Shortly after the start JABBA BOLT moved down checking MCLAREN MYSTIQUE. There were no further racing incidents to report.

-SLEEPWALK DANCE was slow to begin. Along the home straight HOT SOPHIE moved down as PERUZZI BOLONEY moved out causing PERUZZI BOLONEY to check around the heels of HOT SOPHIE and then run wide.

-A swab sample was taken from the winner UNIQUE EDITION.  
-At the point of the turn FIRETAIL made contact with the running rail, and the BLACK KRUGER eased appearing injured causing FEELIN' to run on the heels of and drag down BLACK KRUGER which then dropped back severely checking EMMY GRAY.  
-BLACK KRUGER was vetted after the race, REPORTED TO BE INJURED AND WAS STOOD DOWN FOR 14 DAYS.  
-FIRETAIL was vetted after the race with NO INJURY DETECTED.  
-EMMY GRAY was vetted after the race, REPORTED TO BE INJURED AND WAS STOOD DOWN FOR 21 DAYS.

<b>Race 8</b>	<b>TABCORP GRADE 5 SERIES FINAL</b>	<b>455m</b>	<b>Grade 5</b>

-On the first turn BUY ME DIAMONDS raced awkwardly for several strides then shortly after CANYA CHASE moved down checking EXCITING TIMES causing EXCITING TIMES to stumble. Along the home straight SUPERSTAR CHASE moved out checking SWIFT TIMING and CANYA CHASE causing both greyhounds to race wide.  
-BUY ME DIAMONDS was vetted after the race with NO INJURY DETECTED.  
-Stewards questioned Mr. H. Brown, representing trainer Mr. T. Murray, regarding the performance of BUY ME DIAMONDS. Mr. Brown was specifically directed under GAR75 to report the outcome of a follow up veterinary examination.

 -TIME'S RIGHT was vetted after the race REPORTED TO BE INJURED AND WAS STOOD DOWN FOR 14 DAYS.
