#### Race 1 G-SIX GREYHOUND ADOPTION PROGRAM SA MAIDEN STAKE 400m TGM

- -A swab sample was taken from the winner PABLO'S PUP.
- -EMERLEY BURNER and HAYRIDE SMITH were both slow to begin. Along the home straight HAYRIDE SMITH ran wide.

#### Race 2 G-SIX NIXON'S FUNCTION CENTRE MAIDEN STAKE

400m TGM

- -A swab sample was taken from the winner LONG GULLY WILMA.
- -On the first turn EMERLEY PHANTOM moved down making contact with WOOD VENEER and lost ground as a result. On the turn off the back straight EMERLEY PHANTOM contacted the running rail.
- -EMERLEY PHANTOM was vetted after the race with NO INJURY DETECTED.
- -WOOD VENEER was vetted after the race, REPORTED TO BE INJURED AND WAS STOOD DOWN FOR 7 DAYS.

## Race 3 THE BUNYIP GRADE 5 SERIES FINAL

400m Grade 5

- -A swab sample was taken from the winner ICENI RIVAL.
- -On the first turn GYPSY CRUZ moved out checking ICENI RIVAL. On the turn off the back straight GYPSY CRUZ moved out bumping CROWDZA JUMPIN' and continued to bump CROWDZA JUMPIN' until entering the home straight.

## Race 4 G-SIX DRY CLEANERS (1-4 WINS N/P) STAKE

400m TGSE

- -On the first turn DAZZLING DAISHA moved down checking HAYRIDE DAWSON and DEGAS. On the turn off the backs straight HAYRIDE DAWSON moved out checking DEGAS and NO NOT YET lost ground appearing injured.
- -NO NOT YET was vetted after the race, REPORTED TO BE INJURED AND WAS STOOD DOWN FOR 90 DAYS.

#### Race 5 ACCELL THERAPY (1-4 WINS N/P) STAKE

400m TGSE

-On the first turn EMERLEY REVELLER moved down checking NIGEL LEE. On the turn off the back straight HOPEY GIRL lost ground when tightened between VICTA CHARLIE and GENTLE BURNER, then checked around the heels of GENTLE BURNER.

#### Race 6 SECURE RACING LOGISTICS (5+ WINS N/P) STAKE

400m SE

-There were no racing incidents to report.

## Race 7 GIDDY-UP (1-4 WINS N/P) STAKE

531m TGSE

- CORNER STORE and ROMAN RENEGADE were slow to begin. There were no further racing incidents to report.

## Race 8 GREYHOUND ADOPTION PROGRAM SA (1-4 WINS N/P) STAKE

531m TGSE

- On the turn into the back straight BIG BURNER and BOSSA NOVA JOE bumped. Along the back straight BIG BURNER and LILLEHAMMER raced wide.
- -BOSSA NOVA JOE was vetted after the race, DIAGNOSED WITH POST RACE STRESS AND WAS STOOD DOWN FOR 14 DAYS.

#### Race 9 G-SIX NIXON'S FUNCTION CENTRE (1-4 WINS N/P) STAKE

400m TGSE

- EDIE FINNERAN was slow to begin. OUTBREAK GIRL ran wide around the home turn.

#### Race 10 G-SIX THE BUNYIP (1-4 WINS N/P) STAKE

400m TGSE

- On the turn off the back straight SHINING JEWEL ran onto the heels of DANCE MOVES. There were no further racing incidents to report.

## Race 11 G-SIX GAWLER DRY CLEANERS (5+ WINS N/P) STAKE

- 400m SE
- SILVER TIMOTHY was slow to begin. On the first turn BASHFUL CLOUD moved down taking WATTO'S REVENGE in checking DATA QUEEN and ASTON EMILIO. Along the back straight BASHFUL CLOUD lost ground appearing injured and checked DATA QUEEN when dropping back through the field.
- -BASHFUL CLOUD was vetted after the race, REPORTED TO BE INJURED AND WAS STOOD DOWN FOR 150 DAYS.

## Race 12 G-SIX ACCELL THERAPY (5+ WINS N/P) STAKE

400m SE

- -A swab sample was taken from the winner TWISTED MISSILE.
- -LLOYD'S SHOUT ran wide along the back straight. On the turn off the back straight LLOYD'S SHOUT moved down checking IRINKA JOSH. DOLLY JO and LLOYD'S SHOUT ran wide into the home straight.
- -DOLLY JO was vetted after the race with NO INJURY DETECTED.

STEWARDS NOTES	Stewards inquired into the circumstances surrounding Trainer Mr. Tony Hinrichsen failing to retrieve his greyhound Filthy Phantom from the kennel house for race 6. After assessing all evidence available, Stewards found Mr Hinrichsen guilty of an offence under GAR 46(2) and he was fined the sum of two hundred and fifty dollars (\$250). Stewards advised Mr. Hinrichsen that any further breaches of this rule would be viewed in a more serious manner.  Stewards questioned trainer Mr. Steve Hoffman regarding the scratching of Cloak And Dagger from race 7. Stewards noted Mr. Hoffman's explanation.
