Race 1	METRO ROLLER DOORS MAIDEN STAKE	300m	Maiden
---------------	--	-------------	---------------

-A swab sample was taken from the winner SUSPENSE.
Shortly after the start BILMAN'S BURGLAR moved down bumping SPRING CESC. There were no further racing incidents to report.

Race 2	DAISH IRRIGATION AND FODDER STAKE	300m	Grade 6
---------------	--	-------------	----------------

-ALLEGRA BLISS went up with the lids. Shortly after the start MISS AMITY and CHRISTIE'S LAD came together and bumped.

Race 3	MONTEITH MEATS STAKE	300m	Grade 6

-Shortly after the start MOMBASA MAINE, ALL OUT CRAZY and TRICKERATION came together and bumped, then IROQUOIS LAD lost ground appearing injured.
-IROQUOIS LAD was vetted after the race, reported to be injured and was stood down for 10 days

Race 4	TABCORP MIXED STAKE	300m	Mixed 4/5

-The start of this event was delayed after LEKTRA GUISEPPE became lose behind the boxes. The greyhound was retrieved and vetted prior to the event and passed fit to compete.
-STIR CRAZY was slow to begin. Shortly after the start CRAGGY ISLAND and HESA MARLOW came together and bumped.

-A swab sample was taken from the winner SWEET ON ME.
MR. SPOCK was slow to begin. Shortly after the start EURO FABIO and SLIPPERY JACK made contact. At the 250m SLIPPERY JACK and EURO FABIO made contact and made contact again at the 200m. At the 100m SUPERSTAR CHASE checked around the heels of SLIPPERY JACK.
-MR. SPOCK was vetted after the race, reported to be injured and was stood down for 21 days

-Shortly after the start GOOD ODDS DIANA moved out onto SOL'S BUDDY which then moved out checking DEMOLISHER and LOGGIE BRIDGE. There were no further racing incidents to report.

Race 9	2020 MURRAY BRIDGE STRAIGHT TRACK CUP OPEN SERIES HEAT 5	350m	Open

-NOTORIOUS JIGGS went up with the lids at box rise and began awkwardly as a result.
-The all clear for this race was delayed while Stewards reviewed NOTORIOUS JIGGS leaving the starting boxes. After viewing all available footage, Stewards were satisfied with the beginning of the race and posted ALL CLEAR.

Race 10	2020 MURRAY BRIDGE STRAIGHT TRACK CUP OPEN SERIES HEAT 6	350m	Open

-A swab sample was taken from the winner CALL ME BILLY.
-QUERENCIA was slow to begin. There were no further racing incidents to report.
-QUERENCIA was vetted after the race, reported to be injured and was stood down for 14 days

Race11 SKY RACING STAKE**350m Grade 6**

-Shortly after the start WHEEL BURNER moved down checking WEBLEC BOW. There were no further racing incidents to report.

Race 12 MURRAY BRIDGE COMMUNITY CLUB STAKE**300m Grade 6**

-UNRESTRICTED LAD stumbled upon exiting the starting boxes. At the 200 metres BLIGHT'S PLIGHT moved out making contact with KING PERCY then shortly after BLIGHT'S PLIGHT visibly eased and was reported for failing to pursue.

-BLIGHT'S PLIGHT was vetted after the race with no injury detected. Stewards acting under GAR69A(2)(a) suspended BLIGHT'S PLIGHT for 28 days Murray Bridge Straight Track only and until the completion of a satisfactory trial.

-UNRESTRICTED LAD was vetted after the race with no injury detected. Stewards questioned Mr. G. Pidgeon, representing trainer Mrs. M.Pidgeon regarding the performance of UNRESTRICTED LAD. Stewards noted Mr Pidgeon's explanation and advised the greyhound's performance would be monitored during future events.
