Post-race veterinary examination revealed a left gluteal muscle injury and a 7 day stand down period was applied. Stewards questioned Mr. G. Harris with regard to ZINFANDEL TRACE'S racing manners turn into the home straight on the final occasion. Mr. Harris was advised the greyhound's performance would be monitored during future events. 6 VALPOLICELLA – checked turn into home straight final time. Post-race veterinary examination revealed no apparent injury 7 RITZA PIPER – checked turn into home straight first time. Checked first turn. Post-race veterinary examination revealed no apparent injury. Stewards issued a warning that any future occurrences of BUN VOLCANO escaping the catching pen will result in the greyhound being required to undergo a satisfactory trial before being eligible to be nominated for any further events.</p>
