<p>1 LA BELLA REGINA – checked and lost ground appearing injured at 250 metres. Post-race veterinary examination revealed a left gracilis injury and a 14 day stand down period was applied.</p> <p>2 WEBLEC WONDER – lost ground appearing injured and then hampered approaching winning post. Post-race veterinary examination revealed a left shoulder injury and a 14 day stand down period was applied.</p> <p>4 ELLA'S DESTINY – checked approaching winning post. Stewards questioned Trainer Mr. T. Nobes regarding the greyhounds racing manners at 250 metres. Mr. Nobes was issued with a warning and was advised the greyhound's performance would be monitored during future events</p> <p>6 ECHO SAVIOUR – post-race urine sample.</p> <p>8 WILLOCHRA – visibly eased and turned its head outwards at 250 metres. Turned its head outwards and made muzzle contact with WEBLEC WONDER approaching the winning post and was reported for marring. Stewards in accordance with R123 and pursuant to R127(a) suspended WILLOCHRA for 28 days Murray Bridge straight only and until the completion of a satisfactory trial.</p>
