<p>1 ECHO SAVIOUR – very slow to begin. 8 DARK POTION – visibly eased at the 100 metres, and then again approaching the winning post and was reported for failing to pursue. Post-race veterinary examination revealed lower back soreness and a 14 day stand down period was applied. Post-race urine sample. Stewards acting in accordance with R125 suspended DARK POTION until the completion of a satisfactory trial.</p>

Stewards acting in accordance with R124 and pursuant to R127(a) suspended WIRRULLA LEXI for 28 days Murray Bridge only and until the completion of a satisfactory trial. 4 WHITE LUST – checked at the 300 metres. Post-race veterinary examination revealed a right hind spike wound and a 10 day stand down period was applied. Stewards questioned Trainer Mr. G. Grgurovic regarding the racing manners of WHITE LUST. Mr. G. Grgurovic was advised the greyhound's performance would be monitored during future events. 8 DARK TRACE – checked at the 200 metres. Turned its head inwards at WIRRULLA LEXI and was reported for failing to pursue. Post-race veterinary examination revealed left and right gluteals injury and a 10 day stand down was applied. Stewards acting in accordance with R125 suspended DARK TRACE until the completion of a satisfactory trial.</p>
